Financial support

Centrelink (Services Australia)

- Crisis payment for extreme circumstances (Family and Domestic Violence) must contact within 7 days of circumstances changing. This can be the victim/survivor being forced to flee the home due to DFV or the PUV being removed from the home.
- ▶ Must be receiving or eligible for and income support payment
- ▶ Must be contactable by a social worker to assess your claim.
- ▶ To Claim- call your regular payment line.
- ▶ PLEASE NOTE: There is a maximum number of crisis payments an individual can receive for an extreme circumstance. Once reached you are no longer eligible.
